

Location: Monomoy National Wildlife Refuge, Chatham, MA

Position Title: Plover Technician

Monomoy National Wildlife Refuge (NWR) was established in 1944 to provide habitat for migratory birds and was designated a Wilderness Area in 1970, the only federally-designated Wilderness Area in Southern New England. Sand stretches for eight miles off the elbow of Cape Cod, forming the barrier islands of North and South Monomoy. The refuge provides important resting, nesting



and feeding habitat for migratory birds, with more than ten species of seabirds, shorebirds, and waterbirds nesting on the islands. The refuge also supports one of the largest nesting colonies of common and roseate terns with over 14,000 nesting pairs and approximately 35 pairs of the federally protected piping plover.

Duties: Duties include but are not limited to: daily productivity monitoring of approximately ~35 pairs of piping plovers, monitoring nesting activities in several least tern colonies, monitoring American oystercatchers, posting nesting areas, predator management, data entry, drafting the seasonal report and general maintenance. The technician will also train and oversee daily activities of one plover intern.

Qualifications: Applicants must have the ability to perform the physical duties of the position including being able to hike long distances over soft sand (about 40 miles per work week) and being able to lift and carry up to 50 pounds. Applicants must have prior experience working with nesting piping plovers and supervising staff or volunteers. Applicants must be able to work with minimal supervision and be able to work with the public of all ages in a professional manner regarding sensitive conservation issues. Previous experience with field work in a field camp setting, data collection, bird identification, and an academic background in wildlife biology, zoology, environmental science or a related field are preferred.

Salary: Stipend will be \$500 per week and individuals will be hired through the <u>Northwoods Stewardship</u> <u>Center</u>. The position includes free dorm style housing on the refuge when not in field camp.

Employment Details: Internship is 26 weeks and starts in early April. The position involves working long days, occasional nights and holidays. Schedules may exceed 40 hours per week and will vary frequently in the length of day and start time. Staff will live in one of two remote field camps on the island with other refuge staff for at least 5 days at a time. There is no heat, electricity, or running water in field camp, and limited facilities in a retired light keeper's house. Willingness to ride in motorboats in challenging marine conditions is required. A background check will be required to gain necessary building and computer access at the Refuge.

Closing Date: February 1, 2020, however hiring may begin before the closing date, so applying earlier is strongly recommended.
